

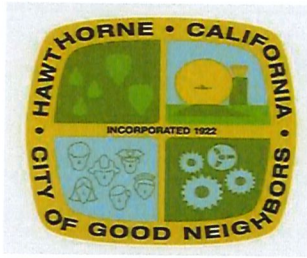




**NOTICE REGARDING EQUALIZATION OF WEED
