#### **SUBJECT:**

Resolution No. 8022, a Resolution of the City Council of the City of Hawthorne, California, Authorizing, Approving, & Ratifying the Acceptance of the FY '18-19 State of California Office of Traffic Safety 'Selective Traffic Enforcement Program' (STEP), Grant Number PT19046.

#### **NOTICING PROCEDURES:**

#### **FISCAL IMPACT:**

The Police Department will receive grant funding in the amount of \$120,000.00.

#### **SUMMARY REPORT:**

The State of California, announced the availability of funds that will be awarded through the Federal Fiscal year 2018 Office of Traffic Safety Selective Traffic Enforcement Program (STEP). The goal of our proposed program is to conduct specified traffic related enforcement operations, in conjunction with educational and safety programs, during the grant period

(October 2018 – September 2019). Hawthorne PD will also use a portion of the grant award to send personnel to ongoing traffic enforcement related training, as well as to purchase equipment and supplies necessary to conduct the required enforcement operations and educational programs.

During the grant period, the Hawthorne Police Department will actively participate in several national traffic-related safety campaigns, including, but not limited to: *National Teen Driver Safety Week, National Distracted Driving Awareness Month, National Motorcycle Safety Month, and California's Pedestrian Safety Month.*

Upon approval of the grant award, the City of Hawthorne will receive \$120,000.00. The grant is financed entirely by OTS funds and does not require a cash or in-kind match. In no case may these funds be commingled with any other funds, even other federal funds, nor may funds be used to supplant expenses for which the City of Hawthorne has already appropriated funds.

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA AUTHORIZING, APPROVING & RATIFYING THE SUBMITTAL OF THE FY '18-19 STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP), GRANT NUMBER PT19046.**

**WHEREAS**, the City of Hawthorne is eligible for a Federal allocation of funds from Selective Traffic Enforcement Program (STEP) through the State of California Office of Traffic Safety in the amount of \$120,000.00; and

**WHEREAS**, the City may receive \$120,000.00 of grant funding to use for programs detailed in the OTS application, including the acquisition of equipment and technology that will enhance the service to the local community; and

**WHEREAS**, the City Council of the City of Hawthorne recognizes the need and benefit to the City of Hawthorne residents and to the community as a whole.

**THEREFORE LET IT BE RESOLVED**, by the City Council of the City of Hawthorne as follows:

**Section 1.** The City Council finds that all of the facts set forth in the recitals of this Resolution are true and correct.

**Section 2.** The City Council authorizes, approves and ratifies the submittal of the Office of Traffic Safety Selective Traffic Enforcement Program. The City Manager or the Chief of Police is further authorized to execute the documents necessary to receive grant funding through the Office of Traffic Safety and administer such grant on behalf of the City of Hawthorne, subject to minor clerical changes by the City Attorney.

**Section 3.** This authorization is effective until rescinded by the City Council of the City of Hawthorne.

## **1. PROBLEM STATEMENT**

The City of Hawthorne is located in Los Angeles County just southeast of the Los Angeles International Airport (LAX). The population is approximately 87,000 residents in an area of about six square miles. The city is surrounded by the 105 freeway on the north, the 405 freeway on the west, and just east of the city is the 110 freeway. Hawthorne is also home to SpaceX, Tesla Motors, and numerous other corporations.

Daytime traffic in Hawthorne is extremely heavy due to several reasons. Hawthorne Blvd is a major north/south thoroughfare that extends from the Palos Verdes Peninsula going into the city of Inglewood where it becomes La Brea Avenue. The street is three and four lanes wide in both directions for most of the city. We have several other main streets that serve as major arteries throughout the South Bay and Los Angeles area including Crenshaw Blvd., El Segundo Blvd., Imperial Hwy., and Rosecrans Ave. All of these streets are heavily traveled during the day and into the evening hours.

In 2015, Hawthorne had a total of 818 traffic collisions with 449 person injured and 5 fatalities. In 2016, Hawthorne had a total of 798 traffic collisions with 485 persons injured and 5 fatalities. Our records for 2017 (to date) show 614 traffic collisions with 352 persons injured and 4 fatalities.

Our total motorcycle involved collisions over the past three years are as follows:

2015 -30 total collisions resulting in 26 injured persons and 2 fatalities.

2016 -22 total collisions resulting in 22 injured persons and 0 fatalities.

2017 -18 total collisions resulting in 17 injured persons and 0 fatalities.

Our total pedestrian involved collisions over the past three years are as follows:

2015 -47 total collisions resulting in 52 injured persons and 0 fatalities.

2016 -56 total collisions resulting in 64 injured persons and 2 fatalities.

2017 -47 total collisions resulting in 47 injured persons and 1 fatality.

Our total bicycle involved collisions over the past three years are as follows:

2015 -36 total collisions resulting in 32 injured persons and 1 fatality.

2016 -26 total collisions resulting in 23 injured persons and 0 fatalities.

2017 -34 total collisions resulting in 31 injured persons and 1 fatality.

While participation in the Selective Traffic Enforcement Program (STEP) has greatly aided our departments' traffic safety campaign, the Hawthorne Police Department, in conjunction with the city of Hawthorne, has also made great strides in trying to reduce death and injuries across the traffic spectrum. Over the past three years the city has introduced clearly marked bicycle lanes on our busiest thoroughfare (Hawthorne Blvd), introduced advanced crosswalks with additional lighting at three separate intersections, continued to participate in the South Bay DUI Task Force (regional DUI enforcement) and introduced and hosted 22 "Ride to Live" motorcycle safety courses free of charge to the general public.

In 2015, Hawthorne had a total of 117 alcohol related collisions with 53 persons injured and 2 fatalities. In 2016, Hawthorne had 110 alcohol related collisions with 46 persons injured and 3 fatalities. In 2017, we had 91 alcohol related collisions with 30 injured person and 2 fatalities. The City of Hawthorne has an extremely high DUI rate with 341 DUI arrest in 2015, 259 DUI arrests in 2016, and 253 DUI Arrests in 2017.

By far, our two most effective strategies in dealing with DUI's have been saturation patrols and DUI checkpoints. In particular, the DUI checkpoints have been very successful with well-publicized checkpoints regularly receiving attention on social media (especially YouTube). While the authors of those YouTube videos are not pro law enforcement, and certainly not pro-checkpoint, the videos do further serve to advise the public of the dangers of driving while intoxicated. The addition of a DUI trailer with breath machine, as well as the participation of trained phlebotomists at our checkpoint, has greatly enhanced the speed of our actual operations and greatly reduced the "down time" of officers involved in bookings.

While our Community Affairs Unit, department website, Facebook and Twitter accounts allow us to reach out to the



community in many ways, we are constantly seeking to expand our interaction with the community in as many positive ways as we can. While officers and supervisors are often tasked with general speaking engagements at various neighborhood watch or citizen group meetings, we have taken a more proactive approach to traffic safety by engaging various parts of our community, especially the motorcycling community, with traffic safety classes and/or information meetings. Our "Ride to Live" program is a free, hands on, riding course for the general public taught by motor officers. The basic course was expanded recently to also include the "Ride to Live Canyon Course" for graduates of the basic course. This class (free also) has motor officers leading motorcyclists on guided rides in the canyons where they receive instruction on how to safely negotiate curves (single greatest cause of single motorcycle collisions). These two classes have placed Hawthorne on the forefront of teaching motorcycle safety to its citizens.

## 2. PERFORMANCE MEASURES

6. Reduce the number of bicyclists injured in traffic collisions.
7. Reduce the number of persons killed in alcohol-involved collisions.
8. Reduce the number of persons injured in alcohol-involved collisions.
9. Reduce the number of persons killed in drug-involved collisions.
10. Reduce the number of persons injured in drug-involved collisions.
11. Reduce the number of persons killed in alcohol/drug combo-involved collisions.
12. Reduce the number of persons injured in alcohol/drug combo-involved collisions.
13. Reduce the number of motorcyclists killed in traffic collisions.
14. Reduce the number of motorcyclists injured in traffic collisions.
15. Reduce hit & run fatal collisions.
16. Reduce hit & run injury collisions.
17. Reduce nighttime (2100 - 0259 hours) fatal collisions.
18. Reduce nighttime (2100 - 0259 hours) injury collisions.

### B. Objectives:

1. Issue a press release announcing the kick-off of the grant by November 15. The kick-off press releases and media advisories, alerts, and materials must be emailed to the OTS Public Information Officer at pio@ots.ca.gov, and copied to your OTS Coordinator, for approval 14 days prior to the issuance date of the release.	<b>Target Number</b> 1

<b>A. <u>Phase 1 – Program Preparation</u> (1<sup>st</sup> Quarter of Grant Year)</b>	
<ul style="list-style-type: none"> <li>◦ The department will develop operational plans to implement the “best practice” strategies outlined in the objectives section.</li> <li>◦ All training needed to implement the program should be conducted this quarter.</li> <li>◦ All grant related purchases needed to implement the program should be made this quarter.</li> <li>◦ In order to develop/maintain the “Hot Sheets,” research will be conducted to identify the “worst of the worst” repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver’s name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.</li> <li>◦ Implementation of the STEP grant activities will be accomplished by deploying personnel at high collision locations. <u>Media Requirements</u></li> <li>◦ Issue a press release announcing the kick-off of the grant by November 15, but no earlier than October 1. If unable to meet the November 15 date, communicate reasons to your OTS Coordinator. The kick-off press releases and any related media advisories, alerts, and materials must be emailed for approval to the OTS Public Information Officer at <a href="mailto:pio@ots.ca.gov">pio@ots.ca.gov</a>, and copied to your OTS Coordinator, 14 days prior to the issuance date of the release.</li> </ul>	
<b>B. <u>Phase 2 – Program Operations</u> (Throughout Grant Year)</b>	
<ul style="list-style-type: none"> <li>◦ The department will work to create media opportunities throughout the grant period to call attention to the innovative program strategies and outcomes. <u>Media Requirements</u></li> <li>◦ Send all grant-related activity press releases, media advisories, alerts and general public materials to the OTS Public Information Officer (PIO) at <a href="mailto:pio@ots.ca.gov">pio@ots.ca.gov</a>, with a copy to your OTS Coordinator. The following requirements are for grant-related activities and are different from those regarding any grant kick-off release or announcement. <ul style="list-style-type: none"> <li>◦ If an OTS-supplied, template-based press release is used, there is no need for pre-approval. however, the OTS PIO and Coordinator should be copied when at the same time as the release is distributed to the press.</li> <li>◦ If an OTS-supplied template is not used, or is substantially changed, a draft press release shall be sent to the OTS PIO for approval. - Space permitting, include the OTS logo, on grant-funded print materials; consult your OTS Coordinator for specifics and format-appropriate logos.
- Contact the OTS PIO or your OTS Coordinator, sufficiently far enough in advance of need, for consultation when deviation from any of the above requirements might be contemplated

**C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)**

- Invoice Claims (due January 30, April 30, July 30, and October 30)
- Quarterly Performance Reports (due January 30, April 30, July 30, and October 30)
  - Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
  - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
  - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
  - Collect, analyze and report statistical data relating to the grant goals and objectives.

**4. METHOD OF EVALUATION**

Using the data compiled during the grant, the Grant Director will complete the “Final Evaluation” section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant’s accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

**5. ADMINISTRATIVE SUPPORT**

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.

All subrecipient law enforcement agencies shall comply with California law regarding profiling. Penal Code section 13519.4, subdivision (e), defines "racial profiling" as the "practice of detaining a suspect based on a broad set of criteria which casts suspicion on an entire class of people without any individualized suspicion of the particular person being stopped." Then, subdivision (f) of that section goes on to provide, "A law enforcement officer shall not engage in racial profiling."
