## **RESOLUTION NO. 8284**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA, APPROVING AND ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 2021-2022

**WHEREAS,** on May 6, 2021, the City of Hawthorne published notice in the Hawthorne Tribune of a budget workshop for review of the City of Hawthorne Proposed Annual Budget for Fiscal Year 2021-2022 to take place during the special meeting(s) of May 18 and May 20, 2021;

WHEREAS, on May 18, 2021, the City Council held a public hearing on the budget workshop for review of the City of Hawthorne Proposed Annual Budget for Fiscal Year 2021-2022;

**WHEREAS**, on June 3, 2021, the City of Hawthorne published notice in the Hawthorne Tribune of the proposed adoption of the City of Hawthorne Proposed Annual Budget for Fiscal Year 2021-2022, to be held during the regular meeting of June 8, 2021;

**WHEREAS,** the City of Hawthorne FY 2021-2022 Proposed Budget, to begin July 1, 2021 and end June 30, 2022, has been submitted to the City Council for review, consideration and adoption;

**WHEREAS,** Section 3.04.010 of the City of Hawthorne Municipal Code requires that the annual budget of the City of Hawthorne be adopted on or before July 1<sup>st</sup> of each year;

**WHEREAS,** the City Council of the City of Hawthorne wishes to adopt the City of Hawthorne Annual Budget for Fiscal Year 2021-2022;

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HAWTHORNE,

CALIFORNIA, hereby resolves as follows:

**<u>SECTION 1.</u>** The foregoing recitals in this Resolution are true and correct.

**SECTION 2.** The City Council of the City of Hawthorne hereby approves and adopts the City of Hawthorne Annual Budget for Fiscal Year 2021-2022, which, by this reference, is incorporated herein as if fully set forth.

**<u>SECTION 3</u>**. Copies of said Annual Budget are available for inspection and/or copying in the Office of the City Clerk.

<u>SECTION 4</u>. That, effective July 1, 2021, the City Manager is hereby authorized to proceed with the implementation of the work program as incorporated in the approved and adopted City of Hawthorne Annual Budget for Fiscal Year 2021-2022; that he has the authority Resolution No. 8284

to transfer any sum of appropriated funds within a department or function, and that he may carry over as needed to future years' funds approved in this budget for projects, capital improvements, and capital outlay. It shall be the responsibility of the City Manager to determine the priority in which increases in personnel and capital acquisition shall be programmed for accomplishment during this year consistent with the availability of revenue and subject to the requirements of the Hawthorne Municipal Code regarding the expenditure of funds and the employment of personnel.

**<u>SECTION 5.</u>** The City Clerk shall certify to the adoption of this Resolution and thereafter the same shall be in full force and effect.
